1. Page 5, Section I., Paragraph D., Funding, is hereby amended to read:

The projected annualized recurring funding for the Community Action Treatment Team is **\$600,000.00.**

2. Page 6, Section I, Paragraph F., Method of Payment, is hereby amended to read:

Services will be paid on a monthly fixed fee method of payment with a requirement of a minimum caseload of **twenty-five (25) persons served per team per month.** SFBHN may request approval from the Department of Children and Families for alternative targets for a specific Network Service Provider, taking into consideration a Network Service Provider's program-specific staffing capacity, historical funding utilization, estimated community needs, or unique geographic and demographic factors of the service location.

The service targets for the first three months of the contract shall accommodate the phase-in of a new program.
