

THIS AMENDMENT, entered into between the State of Florida, **Department of Children and Families**, hereinafter referred to as the “**Department**,” and **South Florida Behavioral Health Network, Inc.**, hereinafter referred to as the “**Provider**,” amends **Contract No. KH225**.

1. The purpose of Amendment #0014 is to add language to Contract No. KH225 incorporating those provisions required by the National Voter Registration Act (NVRA) of 1993, Pub. L. 103-31 (1993), *sections* 97.021 and .058, F.S., and Chapter 2.048, F.A.C. There is no budgetary impact as a result of this amendment.
2. **Page 28, Attachment I, Section B., Manner of Service Provision, Paragraph 1. Service Tasks, Function 6. Data Collection, Reporting, and Analysis, is hereby amended to add the following paragraph (o):**

(o) National Voter Registration Act (NVRA) of 1993

The Managing Entity shall comply with, and require that all Network Service Providers comply with, the National Voter Registration Act (NVRA) of 1993, Pub. L. 103-31 (1993), sections 97.021 and .058, F.S., and Ch. 2.048, F.A.C., in accordance with the **National Voter Registration Act Guidance Document**, which is incorporated herein by reference and may be located at:

3. **Page 77, Exhibit A, Required Reports, Required Statistics, and Performance Measures, Section B, Line 17, is hereby added to read:**

All provisions not in conflict with this amendment are still in effect and are to be performed at the level specified in the contract.
